### 13th XBRL International Conference Madrid

The **13th XBRL International Conference** in Madrid from 15–19 May 2006 highlighted the rapidly growing range of implementations and projects around the world which are based on eXtensible Business Reporting Language (XBRL). A stream of presentations reported on its successful use in the financial and public sectors, details of new projects and ideas for broader use of the standard.

Links with other organizations were also reinforced, with the **Tax XML** group arranging a two-day meeting to coincide with the XBRL conference, the **European bank supervisors** (CEBS) who are building the COREP and FINREP taxonomies holding a workshop and the credit risk analysis group ICISA also meeting.

With more than 470 delegates from twenty-one different nations, the conference was one of the largest XBRL International conferences to date. Strong participation from countries in Latin America underlined growing interest in that region.

#### Main announcements included:

- The **Bank of Japan** said about 500 financial services companies had been reporting to it in XBRL since February. It was already seeing a significant reduction in the burden of data validation. Having begun with monthly balance sheet information, it was looking to expand the scope of reporting and develop new systems for storing and accessing its XBRL data. The Japanese FSA also attended the conference to learn more about XBRL activities in other parts of the world.
- The **Shanghai Stock Exchange** announced that following the successful launch of its XBRL system for company reporting, covering data from more than 800 companies, it was extending its use of XBRL to cover fund information. It will also provide analysis tools to give investors efficient access to XBRL information in a new data warehouse. It expects its valued-added XBRL information to benefit regulators, analysts, investors and information service providers.

- The UK Revenue, National Bank of Belgium, Belgian Banking Supervisor, Spanish Stock Exchange and Dutch government all reviewed their plans for introduction of XBRL reporting over the coming months, confirming timescales and the achievement of milestones on their projects. The Spanish Securities Regulator has already received more than 12,000 company financial reports in XBRL, while more than 400 banks, some 90% of the banking sector, are now reporting in XBRL to the Bank of Spain.
- Individual companies also reported on new uses of XBRL. **ShinGinko Tokyo** announced the launch of an online loan application service for Small and Medium Enterprises (SMEs) in the Tokyo area in which XBRL is used for loan and financial information. This opens up an important area for the use of XBRL. In Europe, Coface Central Europe and Atradius announced a credit analysis project using XBRL which will go live in August 2006. Italy's MPS Bank and the Borsa Italiana have introduced XBRL into their system for evaluating the credit status of SMEs. MPS is considering the use of semantic techniques to enhance its processes and sees XBRL as a pillar of next-generation business intelligence.
- A series of presentations explained the **European banking supervisors'** COREP and FINREP taxonomies for reporting by credit institutions and discussed steps towards their use. Adoption of the taxonomies and XBRL reporting will help reduce the reporting burden and align supervisory practices. COREP is already well advanced while a final release of FINREP is targeted for September 2006.
- The International Accounting Standards Committee Foundation (IASCF) XBRL team contributed a range of presentations on its taxonomy plans and developments, notably for companies filing to Central Balance Sheet Office (ECCBSO). The team also announced an IFRS—XBRL Network which will advance research and encourage exchange of ideas and knowledge between business and academics.

#### Among speeches at the conference:

- José M. Roldán, Chair of XBRL Spain, and Manuel Conthe,
  President of the Spanish Securities Regulator, CNMV, both made
  welcoming speeches at the opening of the event. They underlined
  Spain's effective steps to adopt XBRL and the opportunities which XBRL
  offers for the future.
- Jaime Caruana, Governor of the Bank of Spain and Chair of the Basel II Committee, spoke about the role of XBRL in Spain and international finance, highlighting the trends and requirements which XBRL can support.
- The **US SEC** Chief Information Officer **Corey Booth** called for simple implementations of XBRL which can create real value in the shorter term. Mr. Booth suggested that using XBRL to encode earnings release information in the US would be a very powerful initial niche for XBRL. Another might be to use XBRL for US company primary financial statements, leaving reporting of notes in XBRL to a later stage. #### **XBRL Organization and Working Groups:**

- The permanent members of the new **XBRL Standards Board (XSB)** were chosen during the conference, following an interview process run by the XBRL International Steering Committee. The new members will now take over from the interim board set up in April. The establishment of the permanent XSB will ensure the continued improvement of the consortium's technical work, with a particular emphasis on interoperability and careful consultation.
- The Specification, Domain, GL and Assurance Working Groups met at the conference, advancing discussions on the Dimensions and Formula specifications, as well as plans for XBRL rendering and versioning.

#### The Dutch Taxonomy Project

The Dutch government is currently working towards the large scale usage of XBRL between businesses and governmental bodies starting as of 1 January 2007.

This project is being considered as producing the largest benefits of all projects in a government program aimed at reducing the administrative burdens on companies with 25 percent.

Unique to this project is the close co-operation between the businesses and the government. In June 2006, this co-operation was formalized in a covenant. At this moment, the covenant has more than 70 covenant parties including market leaders of intermediaries such as accountants and tax consultants as well as market leaders of software suppliers. Simultaneously with the signing of the covenant, the Dutch Taxonomy Project released the first version of the Dutch Taxonomy which enables the electronic exchange of XBRL data regarding the obligatory filing of the annual account, tax declarations and economic statistics of 600,000 businesses.

Out of 175 projects, the Dutch Taxonomy Project won the Dutch National Innovation Prize for projects in the public sector. The project also has had a successful receipt at the 4th Quality Conference for public administrations in the EU in September 2006.

Several countries are interested in using the Dutch model of co-operation regarding the use of XBRL. Australia already adopted the Dutch approach as it is also targeting for XBRL data flows.

### Meetings at Bank of Spain push forward XBRL activities in Europe

Two meetings hosted by the Bank of Spain in early October helped to push forward projects for the use of XBRL in Europe.

The 6th European Bank Supervisors XBRL Workshop on 4 and 5 October covered strategies for implementing the newly released COREP and FINREP taxonomies which cover regulatory reporting by banks in Europe under new regulatory reporting frameworks.

The meeting heard reports from central banks in several countries on their experiences in implementing the two taxonomies, while software vendors demonstrated products which support reporting requirements.

The 1st Technical Meeting on European XBRL Projects on 5 and 6 October reviewed the status of XBRL projects in a range of European countries, including Belgium, France, Germany, Poland, Spain and the UK as well as at the International Accounting Standards Board and Eurostat. It discussed current XBRL developments and the main priorities for new specification modules and other technical documents. Views on priorities will be fed into discussions at the XBRL Standards Board (XSB). Among other things, countries shared experience on taxonomy design and project implementation.

Both meetings discussed expectations for the formula, versioning, and rendering work which are being coordinated by XBRL International.

In total, more than 80 people attended the two meetings, with some 65 at the Bank Supervisors' Workshop and 20 at the Technical Meeting. Organizations represented at the Supervisor's Workshop, held under the auspices of the Committee of European Banking Supervisors (CEBS), included central banks and supervisory authorities from Belgium, Bulgaria, Estonia, France, Finland, Germany, Greece, Hungary, Iceland, Italy, Lithuania, Luxembourg, Netherlands, Poland, Portugal, Spain, and Sweden as well as a number of commercial banking organizations and software vendors.

#### SEC to Rebuild Public Disclosure System to Make It 'Interactive'

#### Washington, D.C., Sept. 25, 2006

Agency Invests \$54 Million in Three Contracts toward Transformation of EDGAR Database Washington, D.C., Sept. 25, 2006 — U.S. Securities and Exchange Commission Chairman Christopher Cox announced today that the SEC has awarded three separate contracts totalling \$54 million to transform the agency's 1980s-vintage public company disclosure system from a form-based electronic filing cabinet to a dynamic real-time search tool with interactive capabilities. The major investment in an "interactive data" system signals the agency's commitment to move away from the model of its current EDGAR database. It also presages widespread adoption of interactive data filing by companies that report their financial information to the SEC — a development that until now has only been a voluntary pilot program.

#### The contracts are:

### ■ Modernize and Maintain the EDGAR Database to Use Interactive Data — \$48 million

The Commission today announced it has awarded a \$48 million contract to Keane Federal Systems, Inc., a McLean, Virginia-based subsidiary of NYSE-listed Keane, Inc., to modernize and maintain the Commission's EDGAR database.

### ■ Complete XBRL Code Writing for U.S. GAAP Financial Statements — \$5.5 million

The Commission is announcing its commitment of \$5.5 million to complete the writing of XBRL "taxonomies," or computer labels, so that companies in all industries can file their financial reports. The SEC is contracting with XBRL US, Inc., which is responsible for development of the computer standard in America.

#### ■ Interactive Data Tools for Investors — \$500,000

The Commission announced today that it has awarded two separate contracts to Rivet Software and Wall Street on Demand, leaders in interactive data software development, to provide a new generation of "interactive" investor tools on the SEC's website, <a href="www.sec.gov">www.sec.gov</a>

### XBRL — US to Become Independent Organization

#### New York, Sept. 25, 2006

The American Institute of Certified Public Accountants today announced that XBRL-US will become an independent, not-for-profit organization. Initially formed as a volunteer committee of the AICPA, the new entity will continue as the chartered U.S. jurisdiction of XBRL International, Inc, and as a member-supported entity. As a self-sustaining entity, XBRL US, Inc. will continue to fulfill two goals:

- To support the implementation of Extensible Business Reporting Language (XBRL) in the United States through the development of taxonomies for use by both the public and private sectors;
- To promote adoption of XBRL through conferences, pilot programs, educational materials and events.

In a related development, the Securities and Exchange Commission today announced a \$5.5 million contract with XBRL US, Inc. to complete the development of U.S. financial reporting taxonomies for public use.

#### **August 31, 2006**

- This taxonomy represents International Financial Reporting Standards General Purpose Financial Reporting for Profit-Oriented Entities, Incorporating Additional Requirements for Banks and Similar Financial Institutions (IFRS-GP).
- This taxonomy has the IASC Foundation status "Final." The taxonomy will remain unchanged for 2006.
- The taxonomy is based on the IFRS Bound Volume 2006. The contents of the 2006 version of the IFRS-GP includes the latest versions of most IFRSs (including IASs and Interpretations) approved up to 31 December 2005, and required to be applied on 1 January 2006 or from a future date.
- This taxonomy will be submitted to XBRL International for Acknowledgement, together with its restated
- Label role submission to the Link Role Registry.
- The taxonomy represents the completion of Phase I:
- Taxonomy Maintenance of the IASC Foundation XBRL Team's IFRS-GP taxonomy Improvements Project.
- 2005 translations of the IFRS-GP will be updated by volunteers for changes in 2006 and made available as soon as possible.

XBRL is growing quickly around the world with increasing participation from individual countries and international organizations. XBRL International is comprised of jurisdictions which represent countries, regions or international bodies and which focus on the progress of XBRL in their area. The consortium of over490companies, associations, and agencies in 19 jurisdictions worldwide are working together to build the XBRL language and promote and support its adoption.

#### **AUSTRALIA**

The main activity for the last couple of months has been on the taxonomy development. XBRL Australia's main focus, other than completing the taxonomy development, is on transitioning the jurisdiction from its start-up and development phase. Much of the awareness battle has been won and we now look to the new challenges of maintaining the momentum as XBRL takes hold. This may require new approaches, a different business model and a new set of skills and resources. The Board is currently investigating the options in this regard and will report in the very near future on a plan to take XBRL Australia forward.

#### **BELGIUM**

#### **Status**

XBRL Belgium became an established jurisdiction on 15 July 2006 and is still hosted by the National Bank of Belgium.

**Jurisdictional leader:** Luc Dufresne, Chair XBRL Belgium, Microeconomic Information, National Bank of Belgium

#### **Projects**

The Belgian jurisdiction continues to make progress on XBRL development and adoption, particularly in the regulators' environment.

The National Bank of Belgium is involved in two important projects:

- The final version of the Belgian taxonomy be-fr-pfs-ci-2006-10-01 will be published in October 2006. This taxonomy is based on the Belgian Gaap and will be used by non-financial companies for the drawing up of their statutory annual accounts to be filed with the National Bank (Central Balance Sheet Office CBSO) in the form of XBRL-instance documents as from April 2007. It will be totally transparent for the final user through the use of an Internet application "free of charge" allowing him to fill in and to validate its annual accounts before filing it.
- The National Bank of Belgium and the Banking, Finance and Insurance Commission (BFIC) have developed a Belgian taxonomy, reflecting the national regulatory IFRS reporting scheme. The taxonomy was created as an extension of the IFRS taxonomy of the IASCF and has been used since January 2006 for the consolidated regulatory reporting of credit institutions. The first reports have been received in June 2006.

People from National Bank of Belgium and from BFIC (CBFA) are also deeply involved in the FINREP and COREP projects.

The Directorate-general Statistics and Economic information (former National Institute for Statistics) is currently involved in a study to develop an XBRL application allowing companies to fill in surveys about their structure, using data from annual accounts. This project is linked with Eurostat and is due to be finalized in 2007.

#### **CANADA**

The Investment Dealers Association of Canada has recommended a new regulatory reporting system which would be totally electronic, using XBRL and based on an "access equals delivery" model.

The Canadian acknowledged taxonomy for primary financial statements has been updated to reflect the accounting standards issued in the past three years and when it is released at the end of December will be completely up to date. It is still open for review on Trax until November 30. The purpose of this webcast is to review the major changes in the taxonomy, and show how people can contribute to it by commenting on the draft.

#### **GERMANY**

German legislation will introduce mandatory filing of financial statements to an electronic public register — called *Bundesanzeiger* — beginning January 1, 2007. This will concern about 1 million businesses in Germany. XBRL will be the preferred format to deliver the data. While XBRL will not be mandatory, XBRL users will benefit from significant lower fees that the register is charging from the reporting entities. The largest share of reports will use the new released taxonomy GermanAP version2 (covering the German Commercial Code or *Handelsgesetzbuch / HGB)*, but also IFRS and US GAAP are considered. The company in charge for the register is a member of XBRL Germany and is cooperating closely with other members of the German XBRL community in reaching the goal to make XBRL their prevailing reporting medium. Things fit perfect to each other: For instance, Datev — another member of XBRL Germany — is able to generate XBRL reports with very low effort for more than 2 million German entities.

XBRL Germany is expanding their collaboration with the academic sector. In July 2006 the first German XBRL Colloquium with the objectives to identify areas of cooperation and stimulate XBRL related academic studies. Goals are to (i) find partners in adapting XBRL to the market, (ii) promote the reputation of XBRL through those partnerships, and (iii) make XBRL a known and common matter to a group of people that in the future might take over leadership roles in business and administration. The next XBRL Colloquium is scheduled for October 13, 2006.

### INTERNATIONAL ACCOUNTING STANDARDS COMMITTEE FOUNDATION (IASC Foundation)

In March 2006, the IASC Foundation launched a new Web site, <a href="https://www.iasb.org/xbrl">www.iasb.org/xbrl</a>, to showcase the pioneering work of the IASC Foundation's XBRL Team. This Web site includes its XBRL news content as an RSS feed. RSS (Really Simple Syndication) is an easy way to be alerted when new content appears on the XBRL section of the IASB Web site. The Team also launched its XBRL Lab, a research and development centre to prototype new techniques in XBRL taxonomy building and the general use of the XBRL specification for IFRS. Most recently it released an EduCentre — containing a host of online XBRL educative materials including XBRL Fundamentals, an XBRL glossary, webcasts, presentations and XBRL Demonstrations.

The IASC Foundation continues its pioneering and leadership roles in the XBRL International consortium:

- Kurt Ramin, consultant to the Foundation and team leader, holds the position of Chairman of XBRL International for a third term.
- Josef Macdonald, the IASC Foundation XBRL Practice Fellow, is the former XBRL International Domain Working Group Chair and was a member of the interim XBRL Standards Board. He is the current chair of the IFRS XBRL Development Team (IXDT), chair of the IASB IT Discussion Group and leader of the Foundation's XBRL Team of Student Interns.
- The successful XBRL student internship program has a total of six interns from European jurisdictions working on XBRL at the IASC Foundation. They are: Maciej Piechocki (Poland), Haiko Philipp (Germany), Michal Piechocki (Poland), Timo Philipp (Germany), Lukas Pruschke (Germany) and Daniel Gloeckner (Germany).

The IASC Foundation XBRL Team also continues to cooperate on IFRS-based XBRL projects around the world, including the European Central Balance Sheet Data Offices WGIII reduced format project and the New Zealand e-Government (tax and statistics) IR 10 prototype, among others. The Team liaises closely with the FAF, its equivalent US FASB organization, on taxonomy and other XBRL matters.

Recent activities of the IASC Foundation include:

- Releasing the IFRS-GP 2006 taxonomy after successfully trailing the Core Filing TRAX issues management system to capture public comments on earlier drafts of the taxonomy.
- Continuing to release versions of its 2005 and 2006 taxonomies labels in other languages (now 8 languages available)
- Developing an online search engine to locate elements in the taxonomy.
- Continuing to research and publish solutions to the versioning of its IFRS-GP taxonomy and the establishment of an extensions framework the 2 most significant issues it faces related to its taxonomy.

- Completing the second phase XBRL project of the European Committee of Central Balance Sheet Data Offices (ECCBSO) successfully creating 100+ IFRS instances from real company data. This project will be showcased at the XBRL International Philadelphia conference in December. The Team also hosted the Third Working Group meeting at its offices in London earlier this year.
- Commencing work on the development of a taxonomy for IFRS-SMEs. In particular, the Team has begun work considering the potential implications of this project for modeling it in XBRL when it is released as a standard.
- Hosting two observers from the Indonesia Capital Market and Financial Institution Supervisory Agency (BAPEPAM-LK) and assisting them with learning how to extend the IFRS-GP Taxonomy and adapt it for local use, in order to develop a model for XBRL implementation in the Indonesian Capital Market.
- Releasing our XBRL taxonomy convergence projects, which have attracted the largest number of visitors to our new website. These projects will also be showcased at the Philadelphia conference in December.

#### **IRELAND**

XBRL Ireland continues to make significant progress. Membership now includes: Accenture, Central Statistics Office, Companies Registration Office, Deloitte, Ernst & Young, Fujitsu Ireland, The Institute of Chartered Accountants in Ireland, The Irish Bankers Federation, KPMG, Microsoft Ireland, PricewaterhouseCoopers, The Revenue Commissioners and REACH along with a number of prominent academics. REACH is the organization established by the Government of Ireland to develop a framework for electronic government and represents an important endorsement of XBRL within Irish Central Government.

#### Supporting Adoption in Ireland

Pilot studies in the Central Statistics Office are being extended to cover the more significant Balance of Payments area. Pilot studies continue in the Companies Registration Office (CRO) along with evidence of potential pilots in other Irish Government organizations.

#### **Marketing & Communications**

The Irish academic competition hosted by XBRL Ireland has seen a significant increase in entrants in 2006 versus 2005. This is the second year of the competition and included a five fold increase in registrations. The winning entry, from Dublin City University, was impressive both for its focus on the Irish XBRL taxonomy but also for its creative suggestions as to how small companies would best fit within the taxonomy.

XBRL Irelands strategy of providing training to the Irish market continued into 2006 with detailed hands-on training sessions planned for November 2006 along with a number of awareness related open days and member days.

#### **Taxonomy Development**

The Irish GAAP 2.1 Taxonomy has reached acknowledgement stage providing a reliable platform for the reporting of Irish GAAP financial statements in XBRL. A suite of XBRL v2.1 Irish GAAP financial statements for Irish public companies has been developed to support the taxonomy.

The Financial Services Agency announced establishment of the service and system optimization plans to make XBRL mandatory for EDINET (Electronic Disclosure for Investors' NETwork) in 2008.

#### **XBRL** in Banking Business

ShinGinko Tokyo, Limited launched "Electronic Loan Application Service," utilizing e-TAX, national-tax filing system in Japan, and XBRL in April.

This is the first commercial system using e-TAX filing and XBRL application forms in the world.

The Bank of Tokyo-Mitsubishi UFJ launched their web site to obtain financial data in XBRL, attached with e-tax filing, from their loan customer in October.

Financial Supervisory Service (FSS) started test system of XBRL disclosure — Korea Financial Supervisory Service started voluntary test period of XBRL Disclosure for 251 listed companies for DART (Data Analysis, Retrieval and Transfer) System to apply XBRL for the disclosure from August 29, 2006. FSS has the plan to adopt XBRL as official disclosure financial data format from March 2007 for the listed companies after this test voluntary period. During the test period FSS will reflect actual demands from the voluntary companies and will make some improvements based on test. #### **NETHERLANDS**

At the end of September 2006, XBRL Netherlands membership reached 55 companies.

Highlights in the Netherlands are:

The most important XBRL-project in the Netherlands is the Dutch Taxonomy Project lead by the Dutch Government with the support of many organizations, including XBRL Netherlands. The main objective is to reduce the administrative expenses of companies by implementing the electronic filing of financial, tax and statistical statements for all companies (about 600.000) in 2007. The savings for businesses are estimated at 350 million Euros per year.

- The Dutch Taxonomy is being developed and maintained by the Dutch Government and contains the XBRL data-elements to support the electronic filing of the yearly financial statements, corporate tax filings and statistical information. The Dutch taxonomy version 1.0 (2005) will be released at the end of September 2006. Version 1.0 (2006) will be available at the end of 2006.
- On July 9 2006, the Dutch Government and about 66 organizations signed a XBRL Covenant. They agreed on maintaining the Dutch taxonomy, implementing the infrastructure for electronic filing and taking the necessary steps to support delivery of XBRL in 2007.
- The Dutch Government also started to develop an extension on the Dutch Taxonomy to be used by the financial services for credit risk filings (based on Basel II).
- The Dutch Central Bank will be able to receive XBRL-filings (CEBS-project).
- The Dutch Taxonomy Project, XBRL Netherlands and several members like Royal NIVRA organized several conferences, meetings and training session, to provide the information needed.

Near 500 attendees from 50 countries were represented in the conferences. This large event has up 7 parallel tracks due the important number of presentations. The VI European Banking supervisors XBRL workshop is to be held in Madrid on October 4th and 5th. 60 attendees, representing supervisors, vendors and banks have the opportunity to share information and planning related with the implementation of XBRL. The committee of the European Banking Supervisors as finished in September the production release of the Basel II (COREP) and financial reporting (FINREP) taxonomies on XBRL. National Supervisors are currently extending such XBRL taxonomies with the goal to start real reporting on 2007. Most of European Banking Supervisors plan to use XBRL for their new reports. The workshop will be broadcasted by videoconference.

XBRL Spain is preparing to important public events: public sector and XBRL users. These events will take place in the last quarter 2006.

IberoAmerica is an important target for XBRL Spain. On September, a Spanish XBRL delegation was visiting the Treasury Ministry as well as the FSA in Colombia. The translation of the XBRL jurisdiction started kit is being carried out to help the potential Latin-American XBRL jurisdictions. Other projects include a worldwide XBRL reporting chains catalogue as well as a demo centre for financial analyst and interested people.

#### **UNITED KINGDOM**

The jurisdiction, in conjunction with the Institute of Chartered Accountants in England & Wales, held a well attended (over 150 delegates) public conference in June 2006 on the electronic filing of tax returns. The keynote speaker was Lord Carter of Coles, author of a recent report to government, which recommended that all companies should be required to file their company tax returns online, using XBRL, and make payments electronically, for returns due after 31 March 2010.

The accounting review of the current XBRL UK GAAP taxonomy (published May 2004) is continuing to make good progress. A further revision of this taxonomy is expected to be available during the last quarter of 2006, initially for internal review by interested jurisdiction participants.

By September 2006, some 40,000 filings of company accounts had been made to Companies House using XBRL.

#### **UNITED STATES**

Highlights in the United States:

- US SEC invests \$54 million to pave the way for XBRL filing U.S. Securities and Exchange Commission Chairman Christopher Cox announced today that the SEC has awarded three separate contracts totaling \$54 million to transform the agency's 1980s-vintage public company disclosure system from a form-based electronic filing cabinet to a dynamic real-time search tool with interactive capabilities. <a href="http://www.sec.gov/news/press/2006/2006-158.htm">http://www.sec.gov/news/press/2006/2006-158.htm</a>
- US FFIEC The Federal Financial Institutions Examination Council (FFIEC) in the United States says that their XBRL-based Central Data Repository (CDR) continues to be a big success. The CDR system has been in production for over one year as of September 2006, and has successfully published reporting requirements (including data validation criteria) using XBRL, received pre-validated data, and processed over 25,000 Call Reports from financial institutions on behalf of the FFIEC agencies.

As a result of using XBRL, data are ready for analysis sooner, and the communication between financial institutions and the FFIEC agencies is automated and consistent. The FFIEC indicated that additional changes are expected in 2007 — including the publication of dynamically-generated PDF reports to the public using the XBRL tags, and system changes that will facilitate collection of additional data series.

On Tuesday, 27 June 2006, XBRL-US and the FDIC presented a public event to promote the benefits of XBRL for government agencies. This event was hosted by the FDIC at their conference facility in Arlington, VA.

Government CFOs, financial management professionals, ClOs, CTOs, financial and data analysts, and subject matter experts were invited to attend this free day-long conference on XBRL, an XML business information reporting language. XBRL increases the efficiency, accuracy, productivity, and timeliness of financial and data reporting flow-through processing.

Plenary speakers included leaders of various U.S. government standards initiatives as well as leaders in the public sector financial management professional community. A panel presentation and discussion of ongoing XBRL pilot projects showcased a variety of real world XBRL use-cases for the audience. The program included information on

- What is XBRL and how its use changes data into interactive, intelligent data.
- How XBRL makes the creation and processing of internal, external and intra-agency financial reporting better, faster, and cheaper.
- The need for standardization in the reporting process

#### **FRANCE**

France is a working jurisdiction still provisional for some months, with around 27 members (see <a href="www.xbrl.org/fr/frontend.aspx?clk=SLK&val=83">www.xbrl.org/fr/frontend.aspx?clk=SLK&val=83</a>). Major milestones since last progress report are the following:

- The French Banking Commission (1 of the 27 XBRL France members) decided in 2005 to make it mandatory for the banks to transmit their COREP (Reporting for a common solvency ratio COREP COmmon REPorting) and FINREP (common "supervisory financial" reporting for banks consolidated accounts in IFRS FINREP, FINancial REPorting) reports for June 2007, using the XBRL standard for reasons of efficiency and cost.
- The French Banking Commission is currently implementing internally an XBRL project where their own database will be full XBRL compliant and will be able to receive and to treat XBRL COREP and FINREP instances from the whole banking industry. Banks in France are also currently launching their own XBRL COREP and FINREP projects to be ready for June 2007. That has lead to the emergence of the XBRL market.
- Five Working groups are operating in France:
  - Marcom
  - · French GAAP Taxonomy
  - French IFRS Taxonomy
  - Banking Industry Taxonomy (COREP & FINREP) lead by the French Banking Commission
  - · Technical group
- The French IFRS Taxonomy Working group has carried out a large part of the IFRS GP 2005 and 2006 Taxonomy translation in collaboration with XBRL Belgium with the assistance of a very proficient intern Mrs. Catherine Karacok. The translation is being reviewed in the jurisdictions by a review committee until the end of December 06 and the translation will be officially posted on the IASB website as a draft exposure in next January.
- The French GAAP Taxonomy Working Group is working on the achievement of the French GAAP taxonomy for the first half of 2007.
- The French Marcom Working Group is implementing specific events like breakfasts and has set up a quarterly newsletter. Also the 2nd XBRL France Public day for French speaking audience will be planed in Paris for the middle of 2007.

■ To be mentioned last is the arrival in the jurisdiction of industrial newcomers like the Suez Group, which opens the awareness and the adoption of XBRL to others majors players in France than Banks.



#### **SOUTH AFRICA**

XBRL officially launched in South Africa, 27 July 2006. XBRL is an electronic standard for publishing business reporting data that is being adopted around the world. It has been developed by XBRL International, Inc., a global consortium of accounting societies, financial institutions, technology companies and other financial industry constituents working together since 1998. XBRL provides royalty free, XML-based standards for tagging financial information to enable automated production and retrieval of financial and other business information.

XBRL creates fast, efficient, reliable and cheap financial information. The data does not need to be interpreted. XBRL-aware applications enable analysts and investors to track specific data points from company disclosures and electronically integrate them into spreadsheets and other modeling tools. This reduces the amount of time it takes to locate the required data, eliminates re-keying of data into modeling tools and speeds integration of data into analytical models.

The Swedish Companies Registration Office, Bolagsverket, has launched a service for the filing of company accounts in eXtensible Business Reporting Language (XBRL).

The service will accept full annual accounts from small and medium sized entities (SMEs). It covers primary financial statements, notes, the Directors' Report and Audit Report. Several hundred thousand companies are eligible to use the service, which was launched on 1 July.

The service uses taxonomies to categorize concepts in Swedish Generally Accepted Accounting Principles (GAAP) which were developed by the Swedish XBRL jurisdiction. One taxonomy covers annual reporting by SMEs, which follows a standard format, and another covers Swedish audit reporting.

Bolagsverket's service does not yet handle listed companies, which file under International Financial Reporting Standards (IFRS), financial companies, consolidated or interim reports. However, it will gradually extend to these areas, beginning with consolidated and interim reports.

The service supports automatic validation of accounts by software, display in human readable form as PDF files and digital certification of documents.

The Jurisdiction is now working on the Translation of the IFRS taxonomies into Arabic and is also targeting to attract members and stimulate the use of XBRL in the UAE.
