

1 Report General Information

1.1 Form Short Name

Each form on MAGNA has a singular title and number. An abridged name of the form consists of two components: the first component is a letter indicating the name of a reporting entity (Corporations=ת, Mutual Fund Managers=ק, Dual Listed Corporations=C, Mutual Fund Trustees=ג, Offeror in an acquisition offer which is not a corporation =ר Trustee of company's bonds=כ, Portfolio Managing Company=מ, Investment Advising Company=י, Investment Marketing Company=פ, Bank as an employer of Investment Advisers and Investment Marketers=ב). The second component is a three digit number - form's numeration. For example:030ת – is a financial statements reporting form for corporations.

1.2 Report Subject Matter

This field contains the title of a reporting form. Each reporting form has a title related to the event reported on it. This title is displayed on the distribution site.

1.3 Report Reference Number

Reference number is attached by the system itself, to each report on MAGNA. It's a univalent number in the system that consists of the following components:

YYYY (reporting year)

entity's numerical code made up of 2 digit

a running number of 6 digits, which are not consecutive and are reset once a year at the end of the year) For example: 2006-01-123456

1.4 **Report Receipt Time**

Date and Time on which the report was absorbed by MAGNA subsequent to a number of examinations (such as completeness and anti virus). In legal terms the reporter had complied with his reporting requirements only subsequent to the system's receiving date and time. Following absorption by the system the reporter receives a notification which appears on the list of most recent reports.

1.5 **Report Distribution Time**

Date and time on which the report is published on MAGNA

For most reports publication is two minutes subsequent to reception (henceforth – delay time). A report is transmitted into the ISA's distribution system, immediately following its reception, and in case the report is public it is also transmitted to the stock exchange. The aforesaid systems will publish the report only if its advertising date has arrived. Delay between the reception and the publication date is designed to allow all systems to publish the report simultaneously. In most cases the delay time is 2 minutes. However, regarding reports where the stock exchange needs time to consider trade suspension of a particular security the delay can be longer than 2 minutes (in most cases the defined delay is 20 minutes).

Field indicating whether company's securities are traded on the Tel Aviv stock exchange (TASE). If the answer is positive the following the following will appear in the field: "Company's securities are listed for trade at TASE". If the answer is negative the following the following will appear in the field: "Company's securities are not listed for trade at TASE".

- 2.5 Abbreviated name of a company as published by the TASE. This field is not identical to TICKER name of a company on the stock exchange.
- 2.6 **Main Telephone Number Of Reporting Entity**
A telephone number of a reporting entity, which appears in the header of each report.
- 2.7 **AdditionalT elephone Number Of Reporting Entity**
Additional telephone number of a reporting entity, which appears in the header of each report.
- 2.8 **Main Fax Number Of Reporting Entity**
Facsimile number of a reporting entity, which appears in the header of each report.
- 2.9 **Street Name Of Reporting Entity**
Street name listed as the entity's address, which appears in the header of each report.
- 2.10 **Street Number Of Reporting Entity**
Building number listed in the entity's address, which appears in the header of each report.

- 2.11 **City Of Reporting Entity**
Name of city listed in the entity's address, which appears in the header of each report.
- 2.12 **Zip Code Of Reporting Entity**
Zip code listed in the entity's address, which appears in the header of each report.
- 2.13 **Email Address Of Reporting Entity**
Reporting entity's e-mail address that appears in the header of each report.
- 2.14 **Website Of Reporting Entity**
Reporting entity's website address that appears in the header of each report.
- 2.15 **Previous Hebrew Names Of Reporting Entity**
Previous names of the reporting entity in Hebrew.

- 3 **Electronic Signatory Information**
 - 3.1 **Name Of Electronic Signatory**
Name of the electronic signatory, who signs the report.
 - 3.2 **Position Of Electronic Signatory In Reporting Entity**
Electronic signatory's position in the reporting entity.
 - 3.3 **Telephone Number Of Electronic Signatory**
Telephone number of the signatory, which appears in the footer of each report.
 - 3.4 **Fax Number Of Electronic Signatory**
Facsimile number provided by a reporting entity as part of the means of communication, which appears in the footer of each report.

- 3.5 **Email Address Of Electronic Signatory**
Email address provided by the report's signatory as part of the means of communication, which appears in the footer of each report.
 - 3.6 **Company Of Electronic Signatory If Different From Reporting Entity**
Name of the signatory's employing entity, if the employing entity is not a reporting entity. For example: where a signatory is an employee of a law office that provides services to the reporting entity.
 - 3.7 **Street Name Of Electronic Signatory**
Street name listed as the signatory's address, which appears in the footer of each report.
 - 3.8 **Street Number Of Electronic Signatory**
Street name listed as the signatory's address, which appears in the footer of each report.

Name of city listed as the signatory's address, which appears in the footer of each report.
 - 3.10 **Zip Code Of Electronic Signatory**
Zip code listed as the signatory's address, which appears in the footer of each report.
